

### GLMS NEWS 2017 CONTRACT

#### **COMMISSION & TERMS OF PAYMENT**

Charges for advertising space are payable with the order for the space, unless the Advertiser or Agency has established credit. If credit is given on a monthly payment basis, charges are payable by the 15th of the month following publication. Rates for advertising in GLMS News are net. Cash discounts are not available. Visa or Master Card credit cards may be accepted. Credit requests must be made within 30 days of billing date.

#### **GENERAL RATE POLICY**

**Right to Edit or Reject**. The GLMS News may, in its sole discretion, edit, classify, reject or cancel at any time, any advertising copy submitted by an Advertiser.

**Rates.** The GLMS News may revise its advertising rate schedule at any time upon 30 days written notice to Advertiser, and Advertiser may, without penalty, cancel its advertising contract at any time prior to the new rates become effective upon written notice to GLMS News.

**Indemnification.** Advertiser agrees to indemnify, defend and hold harmless the GLMS News from all claims (whether valid or invalid), suits, judgments, proceedings, losses, damages, costs and expenses, of any nature whatsoever (including reasonable attorney's fees for which the GLMS News or any of its affiliates may become liable by reason of the GLMS News' publication of Advertiser's advertising).

Ownership of Advertising Copy. All advertising copy which represents the creative effort of the GLMS News and/or the utilization of creativity, illustrations, labor, composition or material furnished by it, is and remains the property of the GLMS News, including all rights of copyright therein. Advertiser understands and agrees that it cannot authorize photographic or other reproduction, in whole or in part, of any such advertising copy for use in any other medium without the GLMS News' prior written consent.

**Joint and Several Liability.** If advertiser utilizes an "agency", advertiser and agency shall be jointly and severally liable for complying with all the terms of the advertiser's contract, including payment for all advertising.

All rates are net including color pricing.

**No Sequential Liability.** The Advertiser's contract renders void any statements concerning liability which appear on correspondence from Advertiser or its Agency, and is irrevocable without the written consent of the GLMS News accounting department. It is further agreed that the GLMS News does not accept advertising orders or space reservations claiming sequential liability.


